# INFORME DE LA CONFERENCIA DE LANZAMIENTO DEL PROYECTO INTER PARES FINANCIADO POR LA COMISIÓN EUROPEA, CELEBRADA EN EL PARLAMENTO EUROPEO LOS DÍAS 11 Y 12 DE JULIO DE 2019

Los días 11 y 12 de julio de 2019, la Comisión europea y la Fundación *International IDEA* organizaron, en la sede del Parlamento Europeo, la conferencia que marcaba el inicio del proyecto Inter Pares, de cooperación interparlamentaria, financiado por la Unión Europea y en cuya ejecución participará *International IDEA*.

# Jueves 11 julio 2019

Esta primera jornada de la conferencia estaba abierta al público y fue transmitida por streaming a través de Facebook.

La apertura de la reunión a las 9 de la mañana corrió a cargo del **antiguo Presidente del Parlamento Europeo, Sr. Pat COX**, quien realizó una valoración de la situación actual de la UE, y de los retos a los que se enfrenta tanto en el ámbito económico como social, especialmente tras la crisis económica y financiera. Consideró que la UE había sido un éxito hasta ahora, pero que ello no garantiza que lo seguirá siendo en el futuro. Mencionó, desde su perspectiva como ciudadano irlandés y europeo, las graves consecuencias del Brexit, si finalmente se llegara a confirmar. Expresó asimismo su miedo tanto de los supuestos "superpatriotas" como del aumento del fanatismo y de las ideologías extremistas, que suponen una merma de los pesos y contrapesos y llevan a un mundo de líderes fuertes y de instituciones débiles. Recordó asimismo cómo el presidente de Rusia, en una reciente entrevista en el *Financial Times*, ha afirmado que los ideales liberales están obsoletos en el mundo actual. Sin embargo, la Rusia de Putin no es un modelo adecuado para la gran mayoría de los ciudadanos europeos. Frente a esta deriva,

los nuevos líderes deben de promover unas políticas populares sin caer en el populismo, y demostrar que es mejor enfrentarse juntos a los problemas antes que caer en el aislacionismo que nos amenaza. A continuación, aludió al reciente informe realizado por el Parlamento Europeo sobre la valoración de necesidades en el Parlamento de Ucrania, en el marco de una reciente misión de cooperación interparlamentaria.

La Sra. JAGER, Directora General adjunta de Cooperación al Desarrollo (DG DEVCO) de la Comisión europea aludió a la importancia que supone el refuerzo de las capacidades de los parlamentos para la protección de los derechos humanos y para el fortalecimiento de las instituciones. Afirmó que es importante que los parlamentos nacionales se involucren, y subrayó la posibilidad de establecer importantes sinergias. Con objeto de conseguir los objetivos mencionados, la Comisión proporcionará una plataforma de coordinación en asuntos parlamentarios, para que las ayudas de la UE puedan llegar a Parlamentos en todo el mundo.

El **Sr. DUCCI, Director General de Políticas Externas del Parlamento Europeo**, proporcionó una visión histórica de la actividad de promoción de la democracia que ha realizado el Parlamento Europeo en los últimos 5 años, a través de los Grupos de Apoyo Democrático. La experiencia ha permitido adoptar un enfoque global, que comprende el ciclo electoral completo, incluyendo la formación de personal, la mediación (diálogo *Jean Monnet*), la defensa de los derechos humanos, la cooperación con la sociedad civil y el fortalecimiento de capacidades. Esta actividad ha sido, en cada una de sus vertientes, liderada por diputados del Parlamento Europeo, con objeto de mejorar su aceptación por instancias políticas en el parlamento huésped. Finalmente, resaltó la importancia del proyecto Inter Pares y de la cooperación con los Parlamentos nacionales, como socios para el fortalecimiento de capacidades.

La **Sra. BOZKURT, presidenta del Consejo de IDEA**, aludió a la importancia de la democracia desde la perspectiva del desarrollo de los derechos humanos y subrayó la importancia del dialogo.

La **Sra. JABRE, directora de la división de programas de la UIP**, recordó que su organización ha estado intercambiando experiencias de ámbito parlamentario desde 1889 y reconoció que las instituciones parlamentarias necesitan apoyo mutuo y reciproco.

# Sesión 1. Enfoque europeo del reforzamiento de los Parlamentos

A las 10h30 comenzó la primera sesión, que presentó el enfoque de la UE al desarrollo parlamentario desde el punto de vista de la Comisión europea, el Parlamento Europeo y el Servicio Europeo de Acción Exterior (SEAE).

En primer lugar intervino la **Sra. ADAMO, Jefa de Unidad de la DG DEVCO, Comisión europea**, quien consideró que uno de los aspectos más valiosos del proyecto Inter Pares es su enfoque global en la promoción de la democracia y apoyo del multipartidismo.

El **Sr. QUILLE, Jefe de Unidad de Mediación, Parlamento Europeo**, empleó una presentación en power point que mostraba el ciclo electoral y las medidas a adoptar en cada una de las fases del citado ciclo. A continuación, se centró en el proyecto de cooperación con el Parlamento ucraniano, citando de nuevo el informe mencionado por el Sr. COX. En el capítulo 6 de dicho informe se enumeran los retos pendientes. Hizo hincapié en que la labor del Parlamento Europeo es complementaria de la del resto de instituciones de la UE.

El Sr. COSTELLO, Jefe de División de Democracia y Observación electoral, SEAE, cerró esta sesión aludiendo a la necesidad de promover la idea de que la democracia es positiva. Debido a los retos y riesgos comunes, es necesaria la participación de los Parlamentos nacionales. Aludió asimismo a las misiones de observación electoral, que están presidida por un diputado del Parlamento Europeo propuesto por el propio Parlamento Europeo a la Comisión, con el fin de garantizar que la observación electoral no va a perjudicar las relaciones de la SEAE con el país huésped.

## Sesión 2. Inter Pares. Introducción a la cooperación interparlamentaria.

El **Sr. JORRO-MARTÍNEZ, DG DEVCO**, realizó una presentación general del proyecto, incluyendo referencias a sus objetivos, actividades principales, interesados y socios. Insistió en la voluntad de la Comisión europea de evitar duplicidades, por lo que no se realizaría ninguna actividad que ya estuviera siendo abordada por un Parlamento nacional con financiación de la Comisión europea. Insistió en que se trata del primer proyecto global de cooperación interparlamentaria

financiado por la Comisión europea, y que adoptaba un enfoque "inter pares", de cooperación entre iguales, funcionarios expertos en el ámbito parlamentario. El presupuesto previsto será de 5 millones de euros para un periodo de 3 años. Los proyectos serán financiados en un 100% por la Unión Europea.

El **Sr. Jonathan MURPHY, Jefe del proyecto Inter Pares,** *International IDEA*, señaló que la UE es el mayor proveedor de cooperación interparlamentaria en el mundo, y este debe ser también uno de los objetivos principales de *International IDEA*. Subrayó asimismo que la primera medida será identificar los intereses y objetivos del Parlamento con el que se desee cooperar, y así poder presentar un programa de cooperación acorde con sus necesidades.

Sesión 3. El trabajo de los socios en proyectos de intercambio de conocimientos e innovación: AGORA, *iKNOW Politics* y el Centro de Innovación en Parlamentos (CIP).

En esta sesión, moderada por la Sra. ADAMO, Jefa de Unidad en DG DEVCO de la Comisión europea, participaron la Sra. KANDAWASVIKA-NHUNDU, Jefa de Participación Política y Representación en IDEA-AGORA, quien presentó el portal AGORA de intercambio de información y de conocimientos en el ámbito de la cooperación interparlamentaria. Señaló que el mencionado portal ha estado inactivo desde 2018 por falta de financiación, pero mostró su confianza en que la colaboración con la Comisión europea en el proyecto Inter Pares permitiera reactivarlo.

La **Sra. BALLINGTON, Asesora de Participación política en UN Mujeres**, presentó el proyecto *iKNOW Politics*, que tiene por objeto consolidar la mejora de la presencia de mujeres en los últimos años en todos los niveles de representación parlamentaria, tanto en el ámbito político como administrativo. El proyecto que presentó constituye la mayor biblioteca online sobre la participación de las mujeres en la política, y como tal representa un recurso altamente valorado.

La Sra. BABIC, Jefa de Programas de Cooperación técnica de la Unión Interparlamentaria (UIP), Centro para la Innovación Parlamentaria, se centró en el ámbito de cooperación informática y su disponibilidad a cooperar con todos los países para mejorar su capacidad en este ámbito, gracias a una red de

servidores presentes en todas las zonas más relevantes para los proyectos de cooperación (África del Este, África del Norte, América Latina, Caribe y Pacífico).

Una vez finalizada esta sesión, se ofreció una comida de trabajo a los participantes.

Sesión 4. Proyectos de reforzamiento de las capacidades de los Parlamentos financiados por la UE: socios, impacto y lecciones aprendidas

Tras la pausa de la comida, en esta sesión, moderada por la **Sra. VAN DEN EEDE**, **Jefa adjunta de Unidad en DG DEVCO, Comisión europea**, intervinieron representantes de los órganos y entidades que participan en la ejecución de los proyectos de reforzamiento de las capacidades parlamentarias que financia la Unión Europea.

Participaron la **Sra. MULLER, Gestora de proyectos en la Delegación de la UE en Sudáfrica**, que se centró en las necesidades y en los proyectos realizados en Sudáfrica, y el **Sr. GALITCHI, Experto en recursos humanos**, que explicó el proyecto de apoyo de la UE a las instituciones jordanas.

El Sr. GODINHO GOMES, Gestor de proyecto, *Pro PALOP-TL SAI*, del **Programa de Desarrollo de las Naciones Unidas**, se centró en los programas de cooperación interparlamentaria en los países de habla portuguesa en África y en Timor Oriental.

La Sra. SCHWEIGHOFEROVA, asesora legal de la ONG Parlamentarios para la Acción Global, fue la última oradora en esta sesión. Describió la labor de la ONG en la que trabaja, destinada a una cooperación personalizada con diputados, en un nivel principalmente político y adaptado a las necesidades específicas de cada parlamentario, centradas en tender puentes entre el diputado y la sociedad civil.

Sesiones 5 y 6. El papel del mundo académico y la sociedad civil en el desarrollo parlamentario. La experiencia de los Parlamentos Nacionales en el ámbito de los proyectos de fortalecimiento parlamentario financiados por la UE

Tras una sesión centrada en el mundo académico y la sociedad civil, moderada por el **Sr. MILLAR, de la DG DEVCO**, diversos funcionarios de instituciones europeas y parlamentarias procedieron a describir sus respectivas experiencias en relación

con diferentes proyectos de hermanamiento en las que habían participados Parlamentos Nacionales.

En primer lugar, intervino la Sra. AQUARO, jefe de equipo de hermanamientos de la DG Near de la Comisión europea, que explicó diversos aspectos de su trabajo. A continuación, la Sra. VIGOUROUX, jefe de la unidad de cooperación interparlamentaria de la Asamblea nacional francesa, mencionó los proyectos de hermanamiento en lo que ha participado su Cámara con los Parlamentos marroquí y tunecino. El Sr. KOVACS, jefe de departamento de relaciones internacionales de la Asamblea nacional húngara, aludió a que su parlamento ha participado en 16 proyectos, en estrecha colaboración con la Asamblea nacional y el Senado de Francia. Finalmente, el Sr. FITSILIS, del Parlamento heleno, aludió a su experiencia como asesor residente en el proyecto de hermanamiento con el Parlamento de Serbia.

#### Sesión de clausura

La Sra. ADAMO realizó una breve intervención de cierre, que fue seguida de la intervención de la Sra. MACHANGANA, Directora de Programas Globales de *International IDEA*.

#### Viernes 12 de julio de 2019

A diferencia de la jornada del día anterior, los debates e intervenciones del día 12 de julio fueron a puerta cerrada.

#### Presentación y debate de los resultados de los análisis de base

A las 10h comenzó la reunión con la presentación de las conclusiones extraídas de las respuestas de los Parlamentos nacionales al cuestionario enviado por Inter Pares y la Comisión europea, que fue realizada por el **Sr. JORRO-MARTÍNEZ** y el **Sr. MURPHY**, y en el que se destacó que los Parlamentos llevan a cabo la cooperación parlamentaria de diferentes maneras, dependiendo de su organización administrativa. En el debate subsiguiente se planteó un problema nominativo en torno al uso de la cooperación como "capacitación" destinada a los Parlamentos que reciben la ayuda, argumentándose por varios intervinientes que se debía evitar

colocar dichos Parlamentos en una posición similar a la de un estudiante frente a un profesor.

Por otro lado el representante del Parlamento húngaro propuso que todos los Parlamentos tuvieran acceso a las respuestas de los demás Parlamentos, siguiendo la práctica interparlamentaria habitual (CERPD; COSAC...). El **Sr. JORRO-MARTÍNEZ** y el **Sr. MURPHY** respondieron que, al no tratarse de un ámbito estrictamente parlamentario, no se había podido recurrir al CERPD, y que no era la práctica compartir respuestas que no procedían de la Comisión europea, si bien señalaron que se podría replantear la posibilidad de compartir las respuestas, en función de lo que opinaran los Parlamentos nacionales.

# Taller 1. Experiencias de los Parlamentos nacionales de la UE y enfoques de cooperación interparlamentaria

El primer taller de esta jornada fue moderado por el **Sr. RIZZONI, Cámara de Diputados italiana**, y contó con la participación de funcionarios del Parlamento Europeo, de la Cámara de los Comunes británica, de la Asamblea Nacional francesa, del Bundestag alemán y del Congreso de los Diputados. El contenido de este taller tuvo un carácter más general, con presentaciones de las principales actividades de cooperación parlamentaria llevadas a cabo por los citados Parlamentos.

El **Sr. BERNACKI, Parlamento Europeo**, expuso la labor del Parlamento Europeo, desde la experiencia acumulada por la Dirección de Parlamentos nacionales en el Parlamento Europeo, y centrándose en los programas de apoyo democrático en los Balcanes occidentales.

A continuación, el **Sr. WADE y la Sra. USDEN, de la Cámara de los Comunes**, expusieron su experiencia de colaboración con el Parlamento de Myanmar, basada en un acuerdo de cooperación entre el Speaker de su Cámara y Aung San Suu Kyi. A continuación, la **Sra. VIGOUROUX, de la Asamblea nacional francesa**, repasó los proyectos y actividades de cooperación que su Cámara realiza con otros Parlamentos, dirigido a parlamentarios, funcionarios y personal de grupo. El **Sr. GUCKES, del Bundestag alemán,** tomó a continuación la palabra para exponer los programas de cooperación que realiza su Parlamento. Finalmente, el **Sr.** 



**CARBAJAL** intervino para explicar las diferentes actividades y programas de cooperación que se llevan a cabo por el Congreso de los Diputados.

# Taller 2. Prácticas en la cooperación interparlamentaria internacional.

Tras la pausa para el almuerzo, que tuvo lugar en el salón 5 del restaurante de Diputados del Parlamento Europeo, comenzó el segundo taller, que permitió a los funcionarios de distintos Parlamentos compartir ejemplos concretos de capacitación sobre aspectos específicos del funcionamiento de las Cámaras parlamentarias, con un enfoque especial en la inclusión y la innovación.

El moderador fue el Sr. DELTOUR, Director de Servicios Legislativos de la Cámara de Representantes belga, y participaron como oradores principales el Sr. DELÉPINE, DG ITEC del Parlamento Europeo, la Sra. GARCÍA-ESCUDERO, del Congreso de los Diputados; el Sr. DIGNAM y la Sra. CONNOLLY, ambos funcionarios del Parlamento irlandés; y la Sra. SVECOVA, del Parlamento eslovaco.

El Sr. **DELÉPINE** realizó una exhaustiva explicación de los programas de cooperación en materia informática en los que participa el Parlamento Europeo. La **Sra. GARCÍA-ESCUDERO** expuso el contenido y la metodología de los cursos que proporciona el Congreso de los Diputados, tanto de forma presencial como por internet, sobre técnica legislativa y administración parlamentaria. El **Sr. DIGNAM** describió la cooperación realizada por el Parlamento irlandés con el Parlamento ucraniano. La **Sra. CONNOLLY**, por su parte, dedicó su intervención a explicar el funcionamiento de la Oficina Presupuestaria de su Cámara. Finalmente, la **Sra. SVECOVA** aludió al proyecto de hermanamiento de su Cámara con el Parlamento de Moldavia.

# Presentación y debate de las modalidades prácticas de ejecución

Esta sesión permitió al **Sr. JORRO-MARTÍNEZ** y al **Sr. MURPHY** presentar las modalidades concretas de gestión y administración del proyecto Inter Pares. En el anexo 3 se incluye un documento en el que se resumen los elementos más importantes del proyecto Inter Pares.

En primer lugar, se creará una estructura compuesta por los siguientes órganos:

- El Consejo Rector (*Steering Committee*) que se reunirá un par de veces al año con objeto de fijar las directrices estratégicas. Formarán parte de dicho Consejo la Comisión europea, IDEA, el Servicio Europeo de Acción Exterior, el Parlamento Europeo, la UIP y los Parlamentos Nacionales que lo deseen.
- El Grupo de Trabajo de Ejecución (*Implementation Task Force*) está compuesto por el departamento competente de la Comisión, IDEA, y los miembros del Consejo Rector que sean invitados. Este Grupo de Trabajo controla la ejecución técnica de los proyectos y se reunirá con carácter mensual o semanal.
- La ejecución técnica de los proyectos corre a cargo de la Unidad de Gestión del Proyecto (*Project Management Unit*).

En cuanto a la identificación de los proyectos, se está aún perfilando el procedimiento de trabajo, pero existe una preferencia por el siguiente:

- Inter Pares identifica las necesidades de un Parlamento con el que se desea cooperar, de acuerdo con las peticiones que han sido identificadas por el Consejo rector y de acuerdo con las recomendaciones y observaciones establecidas por la delegación de la UE en el país con el que se quiere cooperar.
- Inter Pares comunica a los Parlamentos Nacionales de los Estados miembros la intención de proceder a un determinado programa de cooperación para atender unas necesidades concretas del Parlamento de acogida. Los Parlamentos Nacionales pueden entonces expresar su interés en participar. En esta fase, Inter Pares se pondría en contacto también con aquellos Parlamentos Nacionales de los Estados miembros que consideren que tienen unos determinados conocimientos o habilidades que pueden ser útiles para el proyecto. Inter Pares tendría una base de datos con la información relevante de cada Parlamento Nacional con la finalidad de poder identificar los parlamentos y los expertos más apropiados para cada caso. Inter Pares tratará asimismo de que no siempre participen los mismos Parlamentos, atendiendo a las capacidades de cada Cámara.
- Junto con los Parlamentos Nacionales participantes y con el Parlamento de acogida se procede entonces a la elaboración de la programación con la

identificación de las actividades necesarias para la cooperación con el Parlamento de acogida.

Inter Pares considera que este procedimiento es transparente, permite identificar las habilidades de cada Parlamento Nacional y reduce el riesgo de que los programas, una vez adoptados, sean rechazados por los Parlamentos Nacionales. La desventaja radicaría en que los Parlamentos Nacionales deben implicarse muy pronto en el procedimiento.

En cualquier caso, desde la organización de Inter Pares se puso asimismo de manifiesto que:

- El Grupo de Trabajo de Ejecución será el órgano encargado de identificar los proyectos.
- Los proyectos serán atendidos de acuerdo con prioridades europeas de cooperación, en la medida en que los fondos proceden íntegramente de los presupuestos de la Unión Europea.
- Todos los gastos correrán a cargo de Inter Pares. Sin embargo, Inter Pares no tiene ánimo de lucro, por lo que se cubrirán los gastos de viaje de los expertos, los medios necesarios para hacer su trabajo, y las dietas, si bien Inter Pares no tiene intención de proporcionar un sueldo a los expertos que intervengan en los proyectos procedentes de los Parlamentos Nacionales de los Estados miembros.

El Consejo Rector se reunirá previsiblemente en el mes de octubre. En la actualidad, la Comisión Europea e IDEA están trabajando para proporcionar un listado de países con lo que se considera que pueden aprobarse a la mayor brevedad proyectos de cooperación. El objetivo para 2019 sería identificar 5 proyectos, para lo cual se está trabajando en un listado de 16 posibles países candidatos, tratando de combinar países en diferentes fases de desarrollo y en todas las áreas geográficas.

Tras unas breves intervenciones de la Sra. O'SULLIVAN, directora de asuntos financieros de Inter Pares, y de la Sra. BEECKMANS, administradora principal de programas de Inter Pares, concluyó la conferencia a las 18 horas.

Francesca has been working for the European Commission for nineteen years and has a solid experience in good governance and public administration reform programmes. She organized many conferences concerning civil rights, the fight against racism and extreme-right, hate-crimes. As co-chair of the European Diversity and Integration Network, she lead fact-finding missions to local Muslim communities in Sweden, Belgium, the Netherlands, United Kingdom, Bulgaria and Spain to listen to the experiences of Muslim communities in Europe to make recommendations to the leadership of the Party of European Socialists.

In 2014 she was appointed by His Majesty the King of the Netherlands Knight in the Order of Orange-Nassau.

#### **Patrick Costello**

#### **Keboitse Machangana**

**Rights-based Approach (RBA):** All activities will be carried out in full application of the RBA's five working principles: (1) Applying all human rights (legality, universality, indivisibility), (2) Participation and access to decision-making process, (3) Non-discrimination and equal access (4) Accountability and access to the rule of law, and (5) Transparency and access to information **Multi-party:** The Action will conduct peerto-peer exchanges and organise networking opportunities giving equal opportunity to participate to Members of Parliament from both the opposition and ruling party
